

# Expand tools to keep water and waste alive

# **Project Objective:**

Both water management and waste management has earlier been adopted by the WGEA as central themes. During the work plan period 2002 - 2004 The Netherlands and Norway produced guidance papers for water and waste respectively.

The objective of this project is to identify appropriate ways to promote the ongoing exchange of experiences between SAIs on water and waste audits, and to actively encourage and support audits in the areas of water management and waste management.

# **Project Scope:**

Tools to be developed are:

- 1. Web pages: Provide information on web pages as a staring point when auditing water and waste management.
- 2. Include sessions on water and waste at upcoming INTOSAI WGEA workshops.

# **Planned Methodology and Participants:**

#### 1. Web pages

There is a lot of valuable information on waste and water available on the web site of the WGEA and elsewhere on the Internet. But currently there is no single place on the WGEA web site where an auditor can see the complete inventory of materials available on waste and water. Two new sub-sections of the web site will be created to make the information on these focus areas more easily accessible. The sub-sections will be called "Focus on Waste" and "Focus on Water".

The "Focus on waste" and "Focus on Water" pages may for example contain:

- Electronic versions of the water and waste papers
- Links to environmental audit reports on waste and water
- Links to websites on international agreements
- Links to international organizations' sites
- Links to interesting pages on waste or water respectively, for example the UN water portal, web pages with environmental indicators, etc.

How will the work be undertaken?

- Make a rough outline of categories to be included on the web pages
- Review and gather information on the Internet and from the 5<sup>th</sup> survey
- Produce an electronic version of the papers on waste and water by adding links
- Make information on waste and water audits accessible. We will use the information gathered by the WGEA surveys.
- Gather web addresses and make links to relevant websites

The Netherlands and Norway will be the editors of the web page, and are responsible for determining what content should be included in each of the focus areas, when content should

be added, or updated, how the content should be advertised and promoted, and when and if the content should be archived and removed. The web page will be updated twice a year.

SAIs that have finalized audit reports on water or waste management in 2002 or later, are expected to provide a summary of these audits if not yet on the WGEAs web site. Some SAIs will be asked to test how the "Focus on Waste" and "Focus on Water" function.

Support from the Canadian Secretariat:

- To supply the layout and design standards for the web page
- To add the content on water and waste to the web site
- To maintain the pages (technically), for example replace links when they move to another page, and add new information when available.
- To gather information on new audits on waste and water via the 5<sup>th</sup> WGEA survey.
- To provide Netherlands and Norway with an inventory of the present information on water and waste on the WGEAs website.

#### 2. Workshop sessions

This tool will be to arrange one workshop session on waste and one on water at a working group meeting. The aim is to share more recent experiences in conducting audits in these fields (after the guidance papers were produced). The papers were published in 2004, so we propose to have the workshops sessions in combination with the 11<sup>th</sup> meeting of the INTOSAI WGEA in 2007. To keep waste and water really 'alive', these themes should return frequently in future meetings (for example once every three meetings).

SAIs will be invited to prepare papers of their audit work on water and/ or waste and give presentations during the seminar.

Support from the Canadian Secretariat:

- Organizational set-up similar to other WGEA workshops.
- Place presentations or papers on the WGEA website afterwards.

# **Communication:**

To promote an active use, SAIs will have to be actively informed on the availability of the subsections called "Focus on Waste" and "Focus on Water". Integration in the regular communication instruments of the Working group (like Greenlines, letters and the main web page) and the communication plan would be a good way to achieve this.

### **Possible Final Output:**

1. Develop one web page on waste and one on water at the INTOSAI WGEAs site by the end of 2005.

2. Workshop sessions on waste and water at 11<sup>th</sup> WGEA meeting.
