

Progress Report of ARABOSAI WGEA to be presented to the INTOSAI WGEA meeting, Tanzania 25-29 June 2007

A summary on the status quo of the Regional sub-Committee for the ARABOSAI Environmental Auditing as the SAI of Egypt is its coordinator :

Committee Establishment :

This Sub-committee was established by a decision of the Executive Council taken at its 26th meeting held in Kuwait on 9th to 10th March 1999.

Committee Membership :

The regional sub-committee for the ARABOSAI Environmental Auditing Affairs comprises eight countries: Algeria, Egypt, Jordan, Kuwait, Libya, Morocco, Saudi Arabia, and Tunisia. The SAI of Egypt is the sub-committee coordinator.

Meetings :

the subcommittee has held five meetings :

- First meeting of ARABOSAI RWGEA held in Egypt from 1st to 5th October 2002
- Second meeting held in Amman from 7th to 10th September 2003.
- Third meeting held in Kuwait from 3rd to 6th April 2004.
- Fourth meeting held in Egypt from 21st to 25th September 2005
- the latest (fifth) meeting took place in Tunisia from 19th to 22nd June 2006

Brief on the most Important Achievements :

The committee's key achievements are :

- managing the distribution and analysis of two questionnaires to build a knowledge of environmental auditing at the regional level.
- launching a homepage on the ARABOSAI website.
- Submitting papers on SAI's experiences in environmental auditing (basics, methodologies and methods) in the field of :
- waste (papers presented by all members except Morocco)

- Water (paper presented by SAIs of Egypt, Kuwait and Tunisia).
- Auditing projects sustainable development (Two papers presented by SAIs of Egypt and Tunisia).
- Auditing the Assessing Environmental Impact (Papers presented by SAIs of Tunisia, Libya, Jordan, Morocco and Kuwait).
- Performance auditing on solid wastes (Papers presented by SAIs of Egypt, Saudi Arabia, Algeria and Tunisia).
- Environmental auditing in the field of air pollution (undertaken by the SAI of Egypt, Jordan and Saudi Arabia).
- Performance auditing on grants, loans regional and international assistance in the environmental field (undertaken by the SAI of Algeria and Morocco)
- Auditing the environmental safety of the imported commodities (undertaken by the SAIs of Tunisia and Libya).

Implemented Training Activities

ARABOSAI has held a training seminar on the topic of "Environmental auditing" hosted by the SAI of Saudi Arabia from 24th to 30th September 2005.
