- (iv) The project output draft was circulated among the Steering Committee Members and it has gone through a 30-day exposure (6 May – 6 June 2025) for comments for INTOSAI WGEA Members via online portal.***
- (v) The 23rd INTOSAI WGEA Assembly adopted the document in 3 July 2025.***

The product developed is consistent with relevant INTOSAI Principles and Standards. The structure of the product is in line with the drafting convention of non-IFPP documents.

The product is valid till ***30 September 2031*** and if it is not reviewed and updated by that date, it will cease to be a public good of INTOSAI developed outside the Due Process.
