How is the work programme different?

Before:

- Disparate range of audits and other products in any one financial year
- Cumulative knowledge across the organisation largely untapped.
- Limited ability to engage financial auditors (audit brief complicated)

After:

- Audits and other products grouped with similar topics across a multiple year work programme.
- Topics inform the selection of theme, not the other way round.
- Try for best fit, but not restricted.


Our office themes





- Providing safe drinking water
- Managing competing demands
- Drought, flooding
- Freshwater quality
- Marine environment
- Planning & financing of infrastructure
- Implementing & enforcing water laws
- Adequacy of data
- Impacts of climate change

Inputs - what stakeholders are telling us











Possible break down of water topic Quality, Quantity, Marine

- How good are our water bodies for drinking, swimming, fishing...? (quality)
- How do we deal with having too much water in some places & too little in others? (quantity):
 - Allocation tools
 - Dealing with flooding
- How healthy are our harbours, beaches and oceans? (marine environment)

What is all this telling us?

- Scope water is a large and challenging topic
- Not the right time to deal with marine issues?
- Questionable whether right time to consider freshwater allocation?
- Which suggests freshwater quality should be the focus?

Likely issues/themes

- Ownership issue/indigenous interests/water pricing/economics
- Long term view
- Economy and environment tension trade-offs
- Capacity and capability
- Information/data for good decision-making
- Infrastructure/including planning for climate change effects/sea level rise
- Collaboration
- Innovation/best practice

Potential tools/responses

- 2018 local authority long term plans and 30 year infrastructure strategies
- Performance audits
- Annual audits
- Inquiries?
- Encourage and support cooperative audits PASAI, AGAG
- Other

Impacts we're seeking

- Independent view of water issues in New Zealand good and bad, should the public be concerned about water management issues?
- Contribution to the water debate (some believe it is immature)
- Flag any capability/funding constraints
- Understand the gaps in governance and central government's implementation support
- Best practice/principles for engaging with communities on trade-offs/risk tolerance
